



HUMANITARIAN GROUNDS

- stay at the nursing home -

1. **Application for issuance of approval/extension** of temporary residence in BiH (you may undertake the form at the field office or download from the official website of Service, it has to be duly completed by hand or typed, signed by the applicant of application and printed on one sheet of paper, both sides),
2. **BAM 150 of administrative fee** for approval/extension of temporary residence,
3. **Recent photo**, size 35x45mm,
4. **Copy of passport** - page with data, last entry into BiH, visa for long term residence visa 'D' BiH, time validation of travel document should be at least three months longer than requested period of approval of temporary residence,
5. **Copy of form of registration of alien's residence** - 'white card' (only when he/she submits application for approval of temporary residence),
6. **Copy of last decision/notice** on approved temporary residence or stickers of approval of temporary residence (only when is being submitted for extension of temporary residence),
7. **Certificate** issued by the institution that an alien is admitted at the nursing home,
8. **Contract on accommodation** at the nursing home with indicated payment methods of accommodation at the nursing home (original and copy),
9. **Medical attestation** issued no later than three months prior to the date of submitted application indicating that the alien does not suffer from a disease presenting a threat to public health in BiH, issued by the competent medical institution for conducting medical checks.
10. **Attestation** of the competent authority in the alien's country of origin confirming that no criminal proceedings and penalty for criminal acts have been imposed against him/her. Such certificated shall not be issued latter than six months prior the date of submitted residence application.
11. **Evidence that no criminal proceeding** is being conducted issued by the competent court in BiH, not longer than 6 months prior to submitting application and **certificate on no criminal record** issued by competent Ministry of Internal Affairs in BiH, if checks are not disseminated officially (evidence is not being disseminate when it is approval of residence),
12. **Evidence on alien's means of subsistence** pursuant to the Article 23 of the Law on Aliens (original or verified copy) as it follows:
 - possession of cash in the national or a foreign convertible currency , possession of cash in the national of foreign convertible currency: by the certificate or other document issued by the bank on the state at the bank account; check or other evidence on pension amount; work permit, certificate on amount of earnings based on working engagement issued by employer, contract on work stating the amount of earnings, evidence on earnings and amount of scholarship, or other evidence;
 - possession of any forms of non-cash payment means recognized by the banking system of BiH or means enabling withdrawal of money in BiH, or a guarantee of a bank from BiH which accepts the non-cash payment means possessed by the alien;
 - possession of evidence on paid accommodation at the nursing home;
 - possession of other assets, such as: immovable property in BiH based on which it is possible to secure the means of subsistence during his/her stay in BiH, funds arising from direct foreign investments; manufacturing technical coordination or cooperation, etc.

**All foreign documents must be translated
into one of languages which are in official usage in BiH!**
