



## WORK WITHOUT WORK PERMIT

### - aliens working for the BiH Government -

- 1. Application for issuance of approval-extension** of approval of temporary residence in BiH,
- 2. BAM 150 of administrative fee** for approval-extension of temporary residence;
- 3. Recent photo**, size 35x45 mm (two photos are needed for approval of temporary residence, and one photo for extension of temporary residence) produced on white, bright, thin photo paper;
- 4. Copy of passport** (page with data, last entry into BiH, visa for long-term residence - visa 'D) deadline of validity at least three months longer from period for which the approval of temporary residence is being asked for;
- 5. Copy of form of registration of alien's stay** (only when is being submitted application for approval of temporary residence);
- 6. Copy of last decision on approved temporary residence** or stickers of approval of temporary residence (only when is being submitted application for extension of temporary residence);
- 7. Evidence** that contract has been concluded with the BiH Council of Ministers or the BiH Ministry of Defense, or the BiH Ministry of Justice, or Ministry of Security,
- 8. Evidence** that an alien performs tasks for needs of defense, law system or security of the state, and that he/she improves professionally in these fields, wherein is cited the type of jobs which shall perform and the period of engagement.
- 9. Certificate by the competent authority** on need of alien's engagement in BiH, and that shall bear costs of accommodation, costs of medical treatment, ensure subsistence and pay other costs which may incur during alien's stay in BiH, and costs of placing under surveillance, voluntarily leaving and forcibly removal, as well as other costs of alien's exit from BiH.
- 10. Medical attestation** issued no later than three months indicating that the alien does not suffer from a disease presenting a threat to public health in BiH, (original or certified copy), issued by the competent medical institution for conducting medical checks. The medical certificate is not being added on occasion of residence extension except in extraordinary cases upon the evaluation of competent field office,
- 11. Evidence on secured health insurance** in BiH for alien (insurance policy, copy of health card, evidence on registration at the Fund of health, evidence on paid individual or collective travel health insurance, and other evidences),
- 12. Certificate that there is no criminal proceedings** being conduct against the alien, **and Certificate** that an alien is not being sentenced for criminal act issued by the competent authority of state, where an alien has usual place of stay not older than 6 months, (this evidence is not needed to be disseminated for aliens submitting application for extension of temporary residence except in extraordinary cases upon the evaluation of competent field office),
- 13. Evidence that no criminal proceeding** is being conducted issued by the competent court in BiH, not longer than 6 months prior to submitting application **and certificate on no criminal record** issued by competent Ministry of Internal Affairs in BiH, if checks are not disseminated officially (evidence is not being disseminate when it is approval of residence).

**All foreign documents must be translated  
into one of languages which are in official usage in BiH!**

**All aforesaid evidences are being enclosed in original or certified copy, except evidence of item 5, and 6, and evidence of item 4 must be delivered in two samples, wherein one sample is certified and other in copy.**
