

TEMPORARY RESIDENCE

real estate ownership

- 1. Application for issuance of approval/extension of approval of temporary residence in BiH (you may undertake the form at the field office or download from the official website of Service, it has to be duly completed by hand or typed, signed by the applicant of application and printed on one sheet of paper, both sides).
- 2. BAM 150 of administrative fee for approval/extension of temporary residence,
- 3. Recent photo, size 35x45mm,
- **4. Copy of passport** page with data, last entry into BiH, visa for long term residence visa 'D'- time validation of travel document should be at least three months longer than requested period of approval of temporary residence,
- **5.** Copy of form of registration of alien's residence- 'white card' (only when he/she submits application for approval of temporary residence),
- **6. Copy of last decision/notice** on approved temporary residence or sticker of approval of temporary residence (only when he/she submits application for extension of temporary residence,
- **7. Land-registry certificate** or certificate of deposited contract for real estate in BiH, (certified contract on buying and selling, present or inheritance of real estate is accepted as an evidence only if the books on land registry are not established which is proved by the certificate of competent court)
- 8. Evidence on existence of effective relation with BiH:
 - they have an origins from BiH which is proved by the birth certificate not older than six months, unless
 it is issued without deadline of validation; and/or
 - education of children in BiH; and/or
 - receiving pension in BiH; and/or
 - investing in BiH, and/or
 - evidence that members of close familiy live in BiH.
- **9. Evidence** that an alien the owner of real estate has provided housing which proves by certified statement at the competent authority,
- **10. Evidence** on means for sustenance with guarantee statement on source of income (possession of cash, bank or pension cheque, an evidence on means of cashless payment, or other evidence such as real estate which is basis for provided income, means upon the investments.
- **11. Medical attestation** issued no later than three months indicating that an alien does not suffer from a disease presenting a threat to public health in BiH, (original or certified copy), issued by the competent medical institution for conducting medical checks. The medical certificate is not being added on occasion of residence extension except in extraordinary cases upon the evaluation of competent field office,
- **12**. **Evidence on secured health insurance in BiH** (insurance policy, copy of health card, evidence on registration at the Fund of health, evidence on paid individual or collective travel health insurance, and other evidences),
- **13. Attestation** of the competent authority in the alien's country of origin confirming that no criminal proceedings and penalty for criminal acts have been imposed against him/her. Such certificated shall not be issued later than six months prior the date of submitted residence application, this evidence is not being sent for aliens submitting request for extension of temporary residence except in extraordinary cases upon the evaluation of competent field office.
- **14. Evidence** that no criminal proceeding is being conducted issued by the competent court in BiH, not longer than 6 months prior to submitting application and certificate on no criminal record issued by competent Ministry of Internal Affairs in BiH, if checks are not disseminated officially (evidence is not being disseminate when it is approval of residence)

All foreign documents must be translated at one of languages which are in official usage in BiH!

All aforesaid evidences are being enclosed in original or certified copy, except evidence of item 5, and 6, and evidence of item 4 must be delivered in two samples, wherein one sample is certified and other in copy.
